Profile of the Month

Kieran O'Doherty, PhD



Kieran O'Doherty is an associate professor in applied social psychology at the University of Guelph, where he directs the Discourse, Science, Publics research group. His research focuses on the social and ethical implications of science and technology. In this context, he has published on such topics as vaccines, human tissue biobanks, the human microbiome, salmon genomics, and genetic testing. Kieran's research also emphasizes public engagement on science and

technology. In this regard, he has designed and implemented public deliberations in which members of the public engage in in-depth discussion about ethical aspects of science and technology and collectively develop recommendations for policy. Kieran's research has been funded by the Canadian Institutes of Health Research, The Office of the Privacy Commissioner of Canada, the Ontario Ministry of Research & Innovation, Genome Canada and Genome British Columbia. He is editor of *Theory & Psychology*.

Short Statement:

New scientific and technological solutions never resolve existing problems in a linear and mechanistic fashion. Rather, science and technology emerge within particular societal contexts, characterised by pre-existing relationships, cultural norms, vested interests, and institutional practices. The particular meanings and values that are associated with the application of scientific and technological advances are therefore not self-evident, nor can they easily be predicted. Accordingly, there arise social and ethical implications that often cannot be understood through only abstract analysis; they also require direct engagement with people and groups who are affected by the emergence of those advancements.

All of us are constrained in our perspective of the world by the particular positions in life we hold, the communities we associate with, and our particular life experiences. Experts are no different. Whether scientists, clinicians, or ethicists, we each embody only a limited set of life experiences, perspectives, and values. To develop meaningful responses to social and ethical challenges arising from new science and technology therefore requires identification and engagement with as diverse as possible a range of perspectives. On the one hand, this means working in inter- and multi-disciplinary collaborations. On the other, it means working with patients and broader communities to reflect on the issues and work collectively to develop appropriate responses. Much of my work has focused on this latter issue, experimenting with deliberative democratic ideas about involving broad publics in policy level decisions, and developing methods for implementing these ideas in the context of health, science, and technology.

What: Dr. Matthew Hunt (McGill University), "Moral entanglements and the ethics of closing humanitarian projects"

Abstract: Humanitarian organizations and their staff regularly make and implement decisions to close humanitarian health projects that were initiated in situations of disaster, war or epidemic. Such decisions are frequently challenging to make, and may be contested within organizations. Indeed, they have been described as among the most ethically fraught aspects of this field of practice. In this presentation, I draw on interviews with humanitarian workers, a review of the literature, and Richardson's concept of moral entanglements, to consider the following questions: What is ethically at stake when organizations decide to close a humanitarian project? And, how can humanitarian organizations implement ethical exit strategies? Closing projects is an inescapable aspect of humanitarian healthcare – indeed, almost all humanitarian projects will come to an end. Careful attention to obligations toward local communities and project partners during project closure is therefore a vital component of ethical humanitarian action.
